When used according to directions, ZEPTABS will inhibit the growth of the following organisms: *Thermoactinomyces vulgaris*, *Pseudomonas effusa*, *Pseudomonas aeruginosa*, *Bacillus circulans*, *Bacillus licheniformis*, *Bacillus megaterium* and *Aerobacter aerogenes*. **DIRECTIONS FOR USE:** It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Remove inner package containing tablets from outer plastic bag. Place the package, holes down and tablets facing up, into drain pan at a point as far from the drain hole as possible. Be sure that the single tablet at one end of the package is farthest from the drain hole. In extremely dirty pans it would be helpful to clean the pan before placing the package. The dirt might block the opening in the bottom of the package and inhibit metering of the ZEPTABS. Use one package for each 2 square feet of drain pan area. Replace pouch when tablets have dissolved. **STORAGE AND DISPOSAL:** Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Store in a cool, dry place inaccessible to children. **DISPOSAL:** Do not reuse empty container. Wrap container and put in trash collection.
